"All our affiliates and members are aware that the 12th Bipartite Settlement was signed on 08.03.2024 between the Indian Banks' Association and the workmen unions for a period of 5 years from 01.11.2022 to 31.10.2027. Consequently, the 13th Bipartite Settlement is due from 01.11.2027.

In this connection, the Department of Financial Services, Government of India, has advised all Banks and the Indian Banks' Association to expedite the process of the 13th Bipartite Settlement so that the settlement can be finalized and implemented from 01.11.2027 without delay.

Keeping this in view, the Executive Committee Meeting of the All India State Bank of India Staff Federation, held on 26.06.2026 at New Delhi, has decided to constitute a Committee for consolidating the Charter of Demands to be submitted on behalf of the National Confederation of Bank Employees after receiving suggestions and proposals from all our Affiliates.
