To ensure that members do not miss out on this facility, they are requested to simply produce their valid Bank Identity Card at the Apollo Pharmacy outlet at the time of purchase.

This initiative is another step in our endeavour to bring **practical and tangible benefits to our members and their families in their day-to-day lives**. We request all our affiliates, State Federations and constituent unions to give **wide publicity** to this facility and ensure that the information reaches every member.

- **Exclusions:** This offer is not applicable at pharmacies located inside Apollo Hospitals or at Airport Pharmacies.
- **Billing Code:** Members are requested to inform the Apollo Pharmacy staff to use Billing Code **10497 – NCBE** while processing eligible purchases.

In case members face any difficulty or inconvenience while availing the above discount facility at Apollo Pharmacy outlets, such as non-availability of the discount, difficulty in applying the Billing Code **10497 – NCBE**, or any other issue relating to the implementation of this facility, they may contact the respective Apollo Pharmacy **Single Point of Contact (SPOC)** for their region, whose details are given below. Members are requested to first bring the matter to the notice of the concerned pharmacy staff and, if the issue remains unresolved, contact the respective regional SPOC for necessary assistance.
